

Jonathan Carver Parkway/CR 11 Project

The City of Carver is partnering with Carver County on some much-needed improvements to Jonathan Carver Parkway/CR 11. The project is scheduled for the summer of 2021 and will run from Chaska Boulevard/CR 61 to 4th Street. There's an online open house at www.co.carver.mn.us/jcpimprovements, which contains an overview video, project layout map, flyover video showing the finished project, and an opportunity for you to share your thoughts and feedback via the "comment card."

Water System Expansion Projects

The City of Carver's water system is nearly at capacity to meet the maximum-day demands. In order to accommodate the City's growth and meet future maximum-day water demands, we've identified the need for the following projects as part of the City's Capital Improvement Plan to expand the water system:

- Additional well capacity and watermain piping from the new wells to the water treatment plant.
- Complete upgrades to the existing water treatment plant.
- Expansion of the existing water treatment plant capacity by 1.5 million gallons per day.

Minnesota River Levee Improvement Project

The City of Carver is seeking \$9 million from the State of Minnesota's 2020 Bonding Bill to make improvements, which will lead to the certification of our levee along the Minnesota River. Read more about this project on page 3.

Spring Reminders

<u>All Terrain Vehicle Restrictions</u>: The use of All Terrain Vehicles (ATVs) on public streets, roads, trails, alleys, sidewalks, and bicycle trails is prohibited by City ordinance.

<u>Fire Hydrant Flushing:</u> Each year, City staff systematically open hydrants throughout the City to allow water to flow at a high velocity through the distribution mainlines. This operation helps maintain the City's water clarity and quality, cleans iron and mineral deposits from the watermains, identifies malfunctions of the hydrant and related valves, and ensures adequate water flow is available at the hydrants for the fire department.

Hydrant flushing may cause temporary inconveniences, such as reduction in pressure and aesthetic issues such as discoloration of the drinking water. Discolored water poses no threat to the public's health, but it may stain laundry and if consumed may have an unpleasant taste or odor. Residents should be certain all discolored water is out of their home's plumbing and hot water heater prior drinking or laundering clothes. If you experience discolored water, run the cold water until clear.

<u>Potholes:</u> To report a pothole that needs attention, call the City at 952-448-5353 or fill out an online request on the City's website (www.cityofcarver.com/comment-question-concern/).

<u>Roadway Obstructions:</u> Basketball hoops, landscape materials, dumpsters, and similar objects are prohibited on City streets. All items must be placed on the property or driveway of the owner.

<u>June Utility Statements</u>: The June utility statement will include a federally mandated municipal well test fee of \$9.72. This fee is submitted to the State Department of Health, who then decides which public wells to test throughout the state.

The Building Department is adapting to the stay at home order by using technology to continue regular inspections for residents and contractors. By using Zoom video conferencing, City staff is able to continue working while maintaining the safety of homeowners, contractors, and staff.



If you recently completed a project, please give us a call and we will schedule an online inspection that can close out your project while you may have some extra time at home. The Building Department is also available during regular business hours to discuss your projects and permit requirements.

The Carver Levee

Last month marked 55 years since the historic Minnesota River floods. The crest of 35.07 feet (as determined by the National Weather Service at the gauge in Jordan) on April 11, 1965, is the highest ever recorded.

Following the devastating flood of 1965, the Minnesota River levee in Carver was constructed by community volunteers and local contractors, without the use of engineered drawings or specific design specifications. Although the levee has protected the City for well over half a decade, this significant piece of infrastructure needs to be modernized.

The City of Carver is seeking \$9 million from the State of Minnesota's 2020 Bonding Bill to help fund improvements to the levee. In addition to

investing \$1.2 million in improvements in the last four years in this project, the City has reached out to our County, State, and Federal-level elected officials for their assistance in getting the remainder of this project funded.

"I know how important this project is to the people of Carver and I am committed to advocating for these funds at the State Legislature," said Representative Jim Nash.

The money the City is seeking from these funding sources will be used to make improvements, such as increasing the height of the levee, making the slopes easier to maintain, addressing the issues of structures and vegetation that are within the clear zone, and adding internal drainage to the levee. In

the end, the City's goal is to have a levee that is structurally sufficient and is accredited by the Federal Emergency Management Agency (FEMA).


Save the Date - Saturday, June 13 - City Wide Clean Up Day

ACCEPTED MATERIALS INCLUDE:

- Furniture (disassembled)
- Carpet/Carpet Pads (rolled securely)
- Mattresses and Box Springs
- Miscellaneous Construction Materials

MATERIALS NOT ACCEPTED INCLUDE:

- General recyclables (cans, plastic, glass, paper, cardboard) should be picked up with the regular curbside recycling
- Appliances (washers, dryers, water heaters, a/c, ranges, refrigerators, and so on)
- Electronics (phones, computers, televisions, and so on)
- Hazardous Materials (paint, batteries, oil, tires, bulbs, and so on)
- · Concrete, Bricks, and Shingles
- Brush, Leaves, Grass, and any other organic material
- Items outside of the 8 ft. x 8 ft. x 4 ft. maximum collection area
- The City of Carver and its Contractor have the right to refuse hauling any materials based on safety concerns or hazardous waste regulations.
