### Reservation Policy

- Park Shelters are available April 15 through October 15, weather permitting.
- Shelter rental hours are 7:00 am — 10:00 pm.
- Requests can be made by calling 952.448.5353, Monday through Friday, 8:00 am – 4:30 pm, or at [cityofcarver.com](http://cityofcarver.com).
- A \$5.00 service fee will be charged for all cancellations requested by the individual prior to the reservation date.
- No refunds will be made on or after the reservation date. Extreme weather conditions may be taken into consideration and are subject to the discretion of the City of Carver.
- Reservations are for the shelter only; there may be other events (baseball and softball games) on the fields near the park shelter since this is a public park.

### Shelter Rules

- Park in designated areas.
- Renter is responsible for ensuring the picnic area is free of trash and debris before leaving.
- Park Equipment (picnic tables, etc.) will remain at the present location.
- Alcohol is not permitted at Depot Park and Gazebo Park.
- No hard liquor or glass bottles permitted.
- A liquor license is required in order to sell alcohol.
- All pets must be on a leash, and picked up after.
- Abide by park shelter hours and regulations.
